#### ROYAL LANES TOURNAMENT RULES

- 1. This tournament will be sanctioned through the USBC and all participants must hold a current season's membership card.
- 2. All bowlers must be USBC members in good standing. Any USBC bowler may enter regardless of the state which they reside. Tournament starts August 5, 2017 and ends August 20, 2017.
- 3. Entering average shall be, IN ORDER LISTED, USBC sanctioned (1) Highest of PREVIOUS 3 YEARS or (2) Highest 2016 summer season final average, or (3) Highest 2016-2017 winter season final average if no other average. The 2017 summer season average WILL NOT be eligible for participation in this tournament. Bowlers not qualifying under the above rules will bowl scratch. For average verifications, Association Secretary Signature on standing sheet or printout of final averages from Bowl.com will be required. In addition, all tournament lanes will be freshly oiled prior to every shift.
- 4. Handicap will be 80% of the difference between the bowler's average and 220.
- 5. USBC rule 319a2, 10 pin rule will NOT apply. Rule 319c, Average Adjustments-Rerating, will apply. Rule 319e, Average Adjustment for Entry, will apply...the highest book average over the last 3 years will apply.
- 6. Guaranteed entries close midnight of July 8, 2017. You may reserve dates and times provided they are paid for by July 8, 2017. Entries later than July 8, 2017 may not receive choice of dates or times. No refunds after entry will be provided. Tournament Committee reserves the right to reject any entry form and return the fees.
- 7. WALK-INS WELCOME! All walk-ins must arrive within 1 hour prior to the start of event. As displayed on the entry blank, all entry forms received and paid for prior to July 8, 2017 will be \$26 per event and all entries received after July 8, 2017 and same-day walk-in entries will be \$29 per event.
- 8. Bowlers may enter an unlimited amount of times in the four person team event. The highest Team Score will count toward All Events Score. If the team of the same four members bowls repeatedly, their highest team score counts towards their team standing. No one team composed of the same members can place more than once. Bowlers entering doubles must enter singles and vice versa. Doubles and singles will be bowled consecutively on the same set of lanes with no break between the events. Singles will be bowled first. There will be no more than three pair of bowlers to a pair of lanes.
- 9. Substitutions will be allowed and must be made at least **one hour** prior to the scheduled bowling time with verification of average. Substitutions shall take the place of the original entrant. Substitutes will be entitled to any prize monies or awards earned from their competition. Substitutes will not be liable for any reimbursement of entry fees, prize money or awards to the original entrant. Paid all-events are not transferable unless substitute replaces original entrant in all three events.
- 10. Entrants arriving late will be permitted to bowl with scores to count beginning with the frame in which they begin to bowl. No practice shots will be allowed after tournament play begins. All squads receive 10 minutes of practice.
- 11. Team captains are responsible for informing team members of proper dress, proper conduct during bowling, and to be at the Royal Lanes bowling center one hour before assigned squad time. No short shorts, short skirts, or tank tops will be allowed.
- 12. Any appeal or protest regarding tournament scores shall be made in writing to the Tournament Committee. The action of the Tournament Committee shall be final, unless an appeal is made in accordance with USBC Rule 329.
- 13. Computer/Tele-scores will be official (transposed to score sheets). Team captains will sign team score sheets and individuals will sign doubles and singles score sheets and initial their average. Signatures make the score sheets final and official. Only obvious errors in transposing and addition will be considered valid.
- 14. Prize fund money will be awarded one prize for every seven entries in Team, Doubles and Singles and one for every fourteen entries in both Handicap and Scratch All Events. All prize fund money will be awarded on Handicap basis except Scratch All Events. All prize fees collected in any event will be returned 100% to the participants in that event.
- 15. Prize money will be sent to team captains within thirty days after the close of the Tournament, if there are no disqualifications. Team captains should distribute prize money to their bowlers within seven days.
- 16. The 50/50 is to be conducted by the Royal Lanes Youth League members and shall be distributed as follows: 50% to drawing winner, 50% to Royal Lanes Youth Scholarship Fund.
- 17. No outside food or beverage permitted in facility.
- 18. PREMATURE TERMINATION: Premature termination of the tournament brought about by national emergency, war, or emergency causes relating thereto or therefrom, fire, natural disaster, or any other reason beyond the control of the tournament officials shall cause, to the extent required thereby, all advertised prizes, guaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination


