GREATER ORLANDO FALL CLASSIC MIXED TOURNAMENT RULES

- 1. This tournament shall be certified open to all TNBA/USBC members, and be operated under the tournament rules of TNBA and USBC. Any entrant who cannot show proof or verification of his/her USBC/TNBA membership prior to bowling will be required to purchase the necessary membership on site. TNBA membership cards may be purchased at a cost of\$22.00 each. USBC cards may be purchased at a cost of\$25.00. If said membership cards are shown or proof submitted prior to the end of the tournament, full refunds will be made. Anyone entrant not adhering to the above rule, will not be allowed to bowl in the tournament.
- 2. The Tournament will consist of MIXED Teams and MIXED Doubles events. Doubles on Saturday and teams on Sunday. Both events can be bowled in the same day. Optional singles while bowling doubles. Separate singles division for women and men. Men cannot enter the women's singles and the women cannot enter the men's singles. If you are bowling on more than one team, please send all entries in together. No optional entries will not be accepted after bowling event starts.
- 3. ENTRY DEADLINE: ENTRIES close midnight, Sunday, September 5, 2021 (USBC RULE 310a). The Tournament Director reserves the right to reject any entry for any reason and return any entry fee. Additional squads may be added to tournament prior to last squad.
- 4. PERSONAL CHECKS WILL NOT BE ACCEPTED. Fees in the form of MONEY ORDERS, BANK CHECKS or CERTIFIED CHECKS MADE PAYABLE TO GREATER ORLANDO TNBA must accompany application form. ENTRY FEES \$45 per person /per event. Teams: \$180.00, Prize Fund \$120.00, Lineage/Expenses \$60. Doubles: \$90, Prize Fund \$60, Lineage/Expenses \$30.00, Optional Singles: \$20.00, Prize Fund \$18.00, Expenses \$2.00, All Events: \$10.00.
- 5. ENTRY FORMS MUST SHOW FULL NAMES as shown on USBC, SOCIAL SECURITY NUMBERS will be required for all bowlers who WIN \$600.00 or more per event, prior to our mailing out your check. Multiple Entries Permitted. However, you can cash only once with the same partner. Not more than three (3) players on the same team may re-enter; one (1) player must be dropped and one (1) new one picked up. Teams will consist of (4) players any mixture of men/women may be used in the team event. Doubles will consist of (1) one male & (1) one female. Bowlers can CASH only ONCE with the same partner. Bowlers may PLACE only ONCE in the optional singles event. Pro-bowlers allowed one per team and one per mixed doubles event.
- 6. Entrants must use their highest sanctioned yearbook average based on 2020-21 season. If no 2020-21 season average entrant must use their HIGHEST CURRENT CERTIFIED AVERAGE at the time of bowling, based on a minimum of 21 games. A league standings sheet is required. If none of the above, the bowler must enter with a 210 average. USBC Rule 319a-2, the 10-Pin rule will apply. Any entrant affected by this rule should submit this average change by September 5, 2021. USBC Rule 319d-Reporting prize winnings of \$300.00 or more per event, and USBC Rule 319E-Average adjustment will apply. (If you have been re-rated before, you must report your re-rated average.) Per Rule 319E, any bowler that has been rerated in the previous 12 months during or after tournament must inform the tournament director. Failure by the bowler to do so may result in disqualification.
- 7. USBC RULE 319a-3- It shall be each bowler's responsibility to verify the accuracy of his/her average (whether originally submitted by the bowler, his/her team captain, or others). If the average submitted for entry is higher than required by the tournament rules, the player is handicapped on the submitted average. If the average submitted for entry is lower than required by the tournament rule and results in a lower classification or more handicap; the

- bowler is disqualified. As per USBC RULE 519a-4, all corrections of an entrant's average may be made up to the end of the entrant's first game. Averages must be verified by Sep. 7, 2021.
- 8. If an entrant submits an average higher than his/her true average he/she must live with the lesser handicap and no additional pins may be given him/her. If an entrant submits an average less than his/her true average he/she shall forfeit all prize money, (and any he/she helped to make) and shall be disqualified and subject to suspension from TNBA, USBC.
- 9. Handicap will be 90% of 220 for both men and women. Handicap will be figured individually for each bowler.
- 10. Replacements shall be permitted and bowler must bowl in the position of original entrant. All rules and regulations herein likewise apply to replacements. All changes must be made one hour prior to bowling. Events will be scheduled in the order names are listed on the entry blank.
- 11. All entrants are requested to wear suitable attire. T-shirts, tank tops, halter tops, bare midriffs, spaghetti strap tops, shorts, and sweatpants are not permitted.
- 12. We understand that as bowlers your primary objectives are fun, achievement, and camaraderie. Thus, we encourage any and all of positive enthusiasm that does not negatively impact the tournament. Foul language during competition makes for a stressful bowling environment and shows poor sportsmanship and infringes upon the experiences of fellow bowlers. It is therefore unacceptable to use any sort of audible foul language during the tournament.
- 13. The Tournament Director reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA and USBC. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or there from, fire natural disaster or any other reason beyond the control of the TNBA Orlando Senate will to the extent required thereby, all prizes to be prorated in accordance with the number of entrants who have booted in each of the respective events up to the time of such termination.
- 14. Team Captain must report to the tournament office at least one hour before time scheduled to bowl and present their TNBA, USBC cards for each team member. All changes are to be made, one hour prior to squad time.
- 15. MIXED TEAMS and MIXED DOUBLES will be scheduled and assigned lanes on a first received basis. Team Captains and/or Coordinators will be notified of day and times assigned to bowl. The Tournament Director's squad schedule will be final. No lane changes will be permitted.
- 16. Tardy players will start in frames being bowled with zero being given for each frame missed. If a team refuses to start because a full line-up is not present, they shall forfeit all games, which they decline to bowl. No blind score shall be permitted and a bowler must bowl with and on the same lanes and at the same time his/her team bowls.
- 17. After entry has been received, no fees shall be refunded except in dire emergency, over which
- 18. the tournament director has no control.
- 19. Prize funds will be returned 100% in each event Team, Doubles and Singles. The payout ratio will be at least 1:8 in each event including the optional Singles for Men and Woman.
- 20. If desired you can bowl all events in the same day. Subject to lane availability.
