MIXED TURTLE TOURNAMENT RULES

1. Handicap will be 90% of difference between highest final 2020-2021 Winter League average and 210, 21 or more games must have been bowled in one sanctioned league. If no

previous winter season average, an entrant shall use the highest USBC sanctioned 2022 Winter League 21 game average as of March 13, 2022. Entrants not qualifying under these rules must bowl scratch. City Association Secretary shall be responsible for verifying the average of the individual entrants or yearbook must be sent with entry.

2. All bowlers must be adult USBC members in good standing. ALL PARTICIPANTS WILL BE REQUIRED TO SHOW THEIR USBC CARDS.

3. Teams will consist of 4 members, 2 men and 2 women. Doubles will consist of one man and one woman. Bowlers may re-enter the team event, but no more than two players on one team can place more than once in the prize list for position standings. Bowlers may re-enter doubles but may cash once with the same partner.

4. The team and doubles line-up will be assigned order of bowling, as shown on the entry blank. No changes to line-up will be allowed once they are entered.

5. Entries close midnight, March 13, 2022 (except for re-entries in special squads assigned). After an entry has been accepted by the Tournament Manager, entry fees cannot be refunded. The Tournament Manager reserves the right to reject any entry and any entry fee. Re-entries are cash only.

6. A team or double entrant may re-enter the tournament on the special assigned squads provided one or more have bowled in the tournament prior to the re-entry. Must re-enter at least 1 hour prior to squad.

7. Substitutes will be allowed as long as they are eligible and are checked in, with written verification of average, one (1) hour before time scheduled to bowl. THIS RULE WILL BE STRICTLY ENFORCED. NO SUBSTITUTIONS WILL BE ALLOWED 30 MINUTES PRIOR TO ANY SHIFT. NO EXCEPTIONS. Substitute will bowl in position of original bowler - no changes in line-up.

8. If a bowler is late for any event, a score of zero (0) will be given her/him for each frame missed. All bowlers must be up and ready to bowl when it is their turn, otherwise they will be given a score of zero (0).

9. TEAM CAPTAINS ARE RESPONSIBLE FOR INFORMING THEIR TEAMMATES TO BE AT LANES ONE (1) HOUR BEFORE ASSIGNED SQUAD TIME..

10. Date will be assigned on first come, first served basis. Entries will be scheduled based on Postmark. Each entry must indicate at least three (3) different choices of weekend dates and three different time choices. If any of the three requested dates are assigned to your team there will be no changes.

11. Telescores will be official scores (transposed to paper sheets.) Team captains for team events and individuals for doubles must sign official score sheets. Said signatures will be considered as final approval and only protests of obvious errors in transporting and addition will be considered valid.

12. Prize money will be awarded one (1) prize for each ten (10) entries in teams and doubles. All cash prizes will be awarded on a handicap basis.

13. Prize checks will be sent to team captains within 30 days after the close of the tournament. Prize checks not cashed within 60 days will not be honored by the tournament committee. If a prize check is re-issued for any reason, the stop payment fee charged by the bank will be deducted from the re-issued check. Any changes in Captain/Coordinator must be submitted to tournament manager in writing by current Captain/Coordinator.

14. Rebowling Tournament Games or Frames: Scores lost due to power failure or mechanical failure must be rebowled. No money will be refunded.

15. Any appeal or protest regarding tournament scores shall be made in writing to the Tournament Manager. The action of the Tournament Committee shall be final unless an appeal is made in writing in accordance with USBC.

16. The 10 Pin Rule will not apply--USBC rule 319D will apply..." A bowler who has qualified for a cash and/or merchandise prize of \$300.00 or more in any event, \$500.00 or more in any tournament and \$1000 in all tournaments in the the previous 12 month period must report his/her actual score, position and amount won to the tournament management at time of bowling in a handicap or classified tournament for possible re-rating". Failure to comply with either of these provisions shall be cause to forfeit tournament entry fees and prize winnings. All participants must be familiar with Rule 319d. (Average Adjustment) A bowler whose tournament scores require an adjustment must submit the adjusted average in writing before they roll their first ball in tournament play.

17. The average of a bowler may be adjusted before the entrant bowls in any event. Bowlers who have participated in previous Turtle Tournaments (Mixed, Men's Women's) and bowled 25 or more pins over their entering average MUST report scores bowled for rerating. Any bowler who fails to report 25 or more pins over average in previous tournament as stated above will be disqualified. Not knowing will not be considered a legitimate excuse. It is each bowlers responsibility to be aware of tournament rules. Any bowler that has been re-rated in any tournament in the past 18 months must report re-rated average to tournament director prior to bowling, failure to do so will be cause for disqualification.

18. Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captains or others. If the submitted average is lower than required and results in a lower classification or more handicap, the bowlers scores is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average. In the case of a team of two or more bowlers, the average will be combined to determine if the correct total is higher or lower than the submitted total. Any change in submitted average must be made before the bowler completes the first game of tournament play.

19. Premature termination of the tournament brought about by war, weather, national emergency or emergency causes relating thereto or therefrom, fire, natural disaster or any other reason beyond the control of the Mixed Turtle Tournament shall cause, to the extent required thereby, all advertised prizes, guarantees or otherwise, to be prorated in accordance with their number entrants who have bowled in each of the respective events up to the time of such termination. This includes weather beyond our control.

20. NO TANK TOPS OR SHORT SHORTS ARE ALLOWED – DRESS CODE STRICTLY ENFORCED.

21. Bowlero Augusta doesn't allow bringing into the center any outside food or beverage. This includes, but is not limited to water bottles, Yeti cups, or any other liquid containing device. All food and beverages must be purchased from Bowlero Augusta.

22. Any rule not covered within shall be governed by USBC rules
